## **Deuteronomy 12**

**Focus:** to call the church to a distinct worship of God according to His commands, unlike the way the world worships their gods.

Read the chapter aloud. What is your first reaction to the idea of studying the law of Moses for the next several months on Sundays?

What questions do you have about how the Law of Moses applies to our lives today? (these don't have to be addressed fully tonight. There will be ample opportunity to do that in the weeks ahead!)

What ways are you confident that the Law of Moses does apply and is of value to our lives today?

Verses 2-14 have a lot to with "place", where the people are to worship in the land. Why is this important? What can you learn about dealing with idolatry from this passage?

Verses 15-19 talk about the freedom they have to slaughter and eat meat that is not being offered as a sacrifice. V. 16 prohibits the eating of the blood even in these non-sacrificial meals. What is the symbolism of the blood that makes it so important? In light of Gen. 9.3-5 and Acts 15.19-20, should Christians abstain from eating or drinking blood today? What helps you sort that out? What principles can guide your interpretation of Scripture? (Make sure that this is a conversation where we listen to one another and NOT a time to try to convince everyone that you are right about this puzzling issue)

Verses 1-4 and 28-32 are very similar. What would you say are the main points in these passages?

This chapter expands on the first 2 of the 10 commandments. Which of the 10 commandments is the one you most need to grow in your obedience to?
