## **Deuteronomy 18**

**Focus:** to protect the church from false and idolatrous purveyors of truth by their submission to the teaching of the Word.

Read Deut. 18.1-8. What would be the benefits of the people providing for the Levitical priests rather than the priests paying their own way? how would this bless the people? the priests? how does this compare with NT teaching about paying pastors and teachers? (cf. Gal. 6.6; 1 Tim. 5.17; 1 Cor. 9.13) How can this be a blessing to our church?

Read 18.9-14. What do these practices have in common? Why do you think these practices are so disliked by God? How are these snares tempting believers today? (Note the NT condemnation of similar practices in Acts 19.18, 19; Gal. 5.19-21; Rev. 9.20, 21).

Read 18.15-22. what is the role of the prophet like Moses who is to come? What difference does it make that Christ fulfilled this prophecy according to verses like Acts 3.19-24; John 1.45, 6.14, 7.40? How would you apply the "test" of false prophets in verses 21-22?

The teaching on priests (1-8) and on prophets (15-22) brackets the teaching on abominable practices of consulting false gods (9-14). How is the teaching of the Word to be a safeguard from divination, etc... for you?
